This Amendment No. 1 ("Amendment No. 1") amends and supplements the statement on Schedule 13G initially filed on July 1, 2019 (the "Original Filing") by Boxer Capital, LLC ("Boxer Capital"), Boxer Asset Management Inc. ("Boxer Management"), MVA Investors, LLC ("MVA Investors") and Joe Lewis. This Amendment No. 1 serves as the original filing for Aaron I. Davis ("Aaron Davis" and, together with Boxer Capital, Boxer Management, Joe Lewis and MVA Investors, the "Reporting Persons"). The Original Filing remains in effect except to the extent that it is amended, restated or superseded by information contained in this Amendment No. 1. Capitalized terms used and not defined in this Amendment No. 1 have the meanings set forth in the Original Filing, as amended.

Joe Lewis is the sole indirect beneficial owner of and controls Boxer Management. MVA Investors is the independent, personal investment vehicle of certain employees of Boxer Capital. Aaron Davis is a member of and has voting and dispositive power over securities held by MVA Investors.

The Reporting Persons beneficially own, in the aggregate, 1,772,960 shares of Common Stock. Boxer Capital, Boxer Management and Joe Lewis beneficially own 1,733,583 shares of Common Stock. MVA Investors and Aaron Davis beneficially own 39,377 shares of Common Stock.

The number of shares of Common Stock beneficially owned by the Reporting Persons represent, in the aggregate, 8.0% of the Issuer's outstanding Common Stock (based on 22,026,588 shares of Common Stock outstanding, as of November 12, 2019 as set forth in the Issuer's Quarterly Report on Form 10-Q filed with the Securities and Exchange Commission on November 12, 2019).
